
About the Arts Education Partnership

ESSA: A New Era for the Arts in Education

- In December 2015, the U.S. Congress passed the Every Student Succeeds Act (ESSA) providing state and district leaders with increased flexibility to best meet the needs of all students.
- This increased flexibility allows leaders to find innovative solutions for ensuring that all students have the opportunity to experience a well-rounded education – one that pushes beyond the subjects of reading, writing and mathematics, and includes the arts, sciences and humanities as essential components.
- AEP's report ESSA: Mapping opportunities for the arts will be continuously updated to reflect the most up-to-date information on the state of implementation.







ESSA Highlights for Arts in Education

- New and clear intent to support the Arts replacing "Core Academic Subject" language from NCLB to "Well-Rounded."
- Opportunities for Arts in: Title I, Title II, and Title IV.
- Encouragement for arts integration across subjects, including STEM.
- Protection from removal from targeted Title I programs.





ESSA State Plans – Spring 2017 Submissions

Of the 12 states with plans submitted by April 27:

- 60% of the submitted plans address access and participation rates in arts education as part of state accountability and/or reporting systems. (CT, DC, IL, LA, MA, MI, NJ, NV)
- 70% of the submitted plans address the arts as part of a well-rounded education. (CT, DC, DE, IL, LA, ME, MA, MI, NJ, NM)
- 38% of the state plans call out arts education within their after-school 21st Century Community Learning Centers programs. (CT, LA, MI, NJ, TN)
- States included mention of arts education in other areas of the ESSA plans, including school improvement (DC, IL), professional development (MA, LA), and support for homeless children and youth (IL).

UTAH

Background

- Pro states-rights
- Lowest per pupil expenditure in nation, highest % of tax burden to education; 30.2% of population is under 18.
- Relatively high performing by national standards
- Teacher shortage prompted up to 11% raises and changes to requirements for teacher licensure.

Plan

- ESSA plan discussed in public meetings, but drafted in a very small group, invited writt
- Art and music art noted 3 times
- Addresses specific title programs
- Cathy Jensen on Title IVa committee
- Board recently eliminated the requirement arts in 7th and 8th grade

Conversely

- Board believes elimination of requirement will increase opportunity to take arts courses
- Culture values the fine arts, indigenous, folk, traditional
- Ranks 5th in the nation for arts/cultural employment, 2nd in the nation for attending exhibitions, #1 in the nation for attendance at live music, theatre and dance
- Attitude assumes arts do and will continue to take place in and out of school

Kentucky

- Proposed Accountability System
 - Regulation Passed by Kentucky Board of Education in September
 - Currently in the legislative review process
 - Gap reduction for low-performing student groups
- Maintains high school graduation requirement
- Opportunity and Access components reported through a dashboard in the school report card

Regardless, of NCLB or ESSA, historically, the arts and arts education moves forward:

- Utah Arts & Museums, state agency established in 1899
- Beverley Taylor Sorensen Arts Learning Program \$10 million + from the legislature annually to fund arts specialists in K-6 schools
- Beverley Taylor Sorensen endowed chairs in arts education at 6 institutions of higher education
- State standards in dance, music, theatre and visual arts, endorsements in all four art forms for K-6 teachers
- Professional Outreach Programs in the Schools (POPS) funded by legislature \$4.3 million (14 companies/arts organizations)
- Strong professional associations i.e. Utah Dance Education Organization, the first state affiliate of NDEO
- Active advocacy of Utah Cultural Alliance includes arts education
- UAM/Utah PTA 20 year partnership. UPTA awards arts education grants to schools with active PTA units
- Standards based dance in 30 elementary schools and 137 middle/high schools

School-by-School Accountability

- School Statistics: Minutes of Instruction, Teacher/Student Ratio, Duration
- Funding and Arts Partnerships
- Program Design: Instructional Implementation, Student Scheduling, School Improvement Plans
- Staffing: Planning, Evaluation, PD
- Discipline Specific: Certification, Curriculum, Facility, Presentation
 Opportunities

- Telling the whole story of the power of arts education: student hook, whole-child development, as leader in development of 21st Century skills.
 - State officials, central office staff, site-based administration
- Supporting arts educators as artists in the classroom.
 - Connecting personal modeling of creative process to instruction.
- The addition of "well-rounded" as an accountability measure will address equity and access.

UTAH

Independent of ESSA, and because of Utah's conservative stance, arts education continues with components

mentioned above and initiatives in:

- Advancing STEM/STEAM, First Lady's initiative, promoted by Governor Herbert
- The Hamilton Project
- Continued legislative support for BTSALP and expanding BTSALP all elementary schools
- Concern for elimination of requirements in PE
 and the arts in middle schools by the Board of Education
- Continued increases to state arts agency funding for AE grants
- Utah Cultural Alliance mapping all cultural assets throughout the state, including arts education
