Governor's Arts Awards

Introduction

Most states have a governor's arts awards program to celebrate the best of their arts and humanities ecosystems. Governor's arts awards—which go by different names in various states—recognize individual artists, arts managers, arts educators, creative economy leaders, arts organizations and institutions, and stewards of folk traditions and cultural heritage.

This report considers active governor's arts awards programs, focusing on 42 initiatives managed solely or jointly by state arts agencies (SAAs). It looks at SAA roles and highlights a number of policy and programmatic factors involved, such as nominee eligibility, awards categories, adjudication processes and presentation ceremonies. It is based on a sampling of governor's arts awards program guidelines, nomination forms, press releases, news reports and other materials available on-line.

State Arts Awards Programs by the Numbers

Program Goals

Governor's arts awards lend a high level of visibility to the arts and culture as a public endeavor, an economic asset and a point of state pride. They engage the state's chief executive (and, in some cases, legislators or other high-ranking officials) in promoting the arts. And they are deeply meaningful to awardees, as they represent the highest honor a state can confer in the arts.

Across the country, governor's arts awards programs share similar goals. Collectively, these programs acknowledge and showcase the best of arts and cultural communities. They highlight awardees' statewide achievements—or, in some cases, national or even international successes—related to creativity and/or leadership. They recognize awardees' visions as well as the talent and hard work they bring to bear in realizing them. Some of the programs focus on innovation and the evolution of artistic disciplines, while others celebrate cultural heritage and the tradition bearers who strengthen it. More specific goals of programs include fostering arts learning, collaborations, diversity, inclusiveness, volunteer service, and productive relationships between arts stakeholders and public servants.

Eligibility and Nomination Factors

Eligibility factors for governor's arts awards are also similar among states. For individuals, nomination generally requires legal state residency, a record of achievement, and/or an active practice of arts making, teaching, management, advocacy or support. Basic eligibility for nonprofits organizations, businesses, schools, government agencies and other institutions is often proof of location or work in the state. Ineligible in many states are previous award recipients and members of the adjudication panel as well as SAA staff, council members and their immediate family. In addition, posthumous nominations are not permitted for most programs.

Nomination processes and materials tend to be more statespecific than eligibility factors, though they are many commonalities from program to program. Nearly all programs require the submission of a completed nomination form as well as a statement supporting the nomination, addressing things such as the nominee's work, history and influence. Many states also request or suggest the inclusion of work samples, a brief biography and letters of recommendation. For nominations of individuals, additional requirements may include an artist statement and resume. Programs vary, however, on the necessity and extent of supplemental nomination materials. Examples of these supporting documents are critical reviews, news articles, promotional literature, books, and audio and video recordings. Regarding procedures, typical variables are whether to allow self-nominations, nominations of a single nominee to multiple categories in a single year, and nominations of past nominees for awards not previously received.

Adjudication Methods

There are multiple ways to adjudicate nominations for governor's arts awards. Most commonly, SAAs convene an independent peer-review panel. These panels often include artists, arts managers, and other arts professionals and leaders. Panels in several states also include SAA council members, previous award recipients, educators, members of the business community, citizens at large, local government officials and/or representatives from the governor's office. Panelists' decisions often have to be ratified by the governor. For the sake of equity, inclusion and impartiality, SAAs typically seek demographic and geographic diversity when selecting panelists. Some also require panelists to hail from another state.

State Arts Agency Roles

Partner or coordinate with the governor's office, the state humanities agency or another state agency, the statewide arts advocacy group, and/or a nonprofit arts organization—including groups dedicated to supporting SAA programming—to realize the program.

Establish award categories, eligibility factors and adjudication criteria and update as necessary. (In some states, the adjudication panel has the discretion to bestow an award beyond the set categories.)

Solicit nominations for the awards program via websites, blog posts, newsletters, e-mail blasts and other media and methods.

Manage the adjudication process, which may include convening the selection committee, facilitating the panel-review process and coordinating the final decision with SAA council members and/or the governor's office.

Select the award design, if it is an original piece of art, which may require a separate panel review process.

Organize the awards ceremony, which may include coordinating with the governor's office and/or state legislators, inviting arts leaders to speak, contracting artists to perform, and hiring caters and other event-support staff.

Arrange sponsorships and fundraise for the awards ceremony, which may include seeking donations from individuals, businesses and foundations as well as selling tickets to the event. (Revenues from a cultural endowment fund, when SAAs have one, may offset the need to fundraise.)

Document the awards ceremony through photography, video, social media and other media.

Promote—via videos, photographs, press releases and other means—the awardees and the roles of the governor, legislators and other state leaders in celebrating and fostering the state's arts and cultural community.

SAA councils and staff may be directly involved in the adjudication process. In some states, for example, SAA councils ratify the recommendations of independent review panels. In other states, SAA staff review nominations and recommend award recipients to council members, who in turn make the final decision or make their own recommendations to the governor. Finally, some councils are wholly responsible for the adjudication process, with a council committee undertaking the initial review before the entire council collectively chooses the awardee(s).

Adjudication criteria vary not only depending on the state but also on the award category and its eligibility factors. Review criteria for individual artists, for example, often include artistic excellence, contributions to the arts and culture, peer recognition and a significant record of accomplishments. For arts organizations, factors may include innovation, integrity, length of service and quality of community engagement.

Partnerships and Sponsorships

Nearly every SAA managing a governor's arts awards program coordinates to some degree with the governor's office, the state legislature, the state humanities office, another state agency, a statewide arts advocacy group and/or a nonprofit organization. SAAs that independently run a program generally still work with the governor's office to facilitate the governor's participation in the awards ceremony and/or to secure the governor's final approval of awardees. For SAAs that manage their program in partnership with another entity, there may be cooperation on setting program policies, soliciting nominations, facilitating the adjudication process and/or organizing the awards ceremony. Promoting award recipients, their work and the value of the state's arts and cultural community as a whole are additional points of collaboration.

Many awards programs are supported through contributions or corporate sponsorships. This fosters shared ownership of programs, mitigates the impact on SAA budgets and aligns with how governor's awards programs in other sectors (like education, health and philanthropy) are commonly financed. On a practical level, private funding provides support for receptions, food and beverages, which frequently are unallowable uses of state dollars. Fundraising can be led by SAA council members (in their capacity as volunteer leaders), nonprofit partners or the state arts agency itself. Some programs involve formal sponsorship categories and seek sustaining gifts, while others

approach fundraising more informally. Another way to support governor's arts awards is to sell tickets to the ceremony and advertising space in the event program. It is also possible to link outreach and fundraising—one SAA, for example, encourages state legislators to sponsor and accompany citizens attending the awards ceremony.

Awards Ceremonies

Presentation ceremonies, which are the most visible component of governor's arts awards programs, often take place in locations that demonstrate public support for the arts, such as the state capitol building, the governor's residence or an SAAsponsored statewide arts conference. Likewise, many governors, spouses of governors and lieutenant governors preside over the awards ceremony, present the physical awards and/or speak about the importance of the state's arts and culture. In several states, for example, the ceremony is the forum for the governor's annual "state of the arts" speech.

Governor's arts awards ceremonies, which range from luncheons to formal evening affairs, are typically not only fetes for awardees but also opportunities to showcase the breadth and depth of the state's artistic community. As such, many SAAs arrange for artists to perform during the event and/or for arts leaders, such as an SAA council member or the state poet laureate, to give remarks. Similarly, in at least 10 states, the award itself is an original piece of art created by a state based artist. To increase the accessibility of the ceremonies, which are free in many but not all states, some programs record and share videos of them, and at least one SAA partners with public television to broadcast its event live.

Award Categories

Each governor's arts awards program is unique. Nonetheless, many programs have similar award categories. Here are some of the most common.

Arts advocacy awards recognize the individuals, organizations and institutions that cultivate opportunities for engaging the arts and raise awareness about the state's cultural community.

Arts education awards generally honor teachers but may also recognize schools, school boards and students.

Arts organization awards, which honor the work of arts service groups and arts institutions, are generally inclusive of various arts disciplines.

Business support for the arts awards go to corporate patrons and various types of businesses, including newspapers, TV stations and other media companies.

Community awards recognize exemplary arts based community development, service and placemaking.

Folk/Traditional arts/Heritage awards go to craftsmen, folk artists, arts educators and advocates fostering traditional art forms and cultural heritage.

Government support for the arts awards recognize state legislators, local agencies and other government employees or entities.

Individual artist awards may be discipline-specific or allinclusive.

Leadership awards generally recognize arts managers and arts organizations who strengthen the state's arts community, reducing barriers to cultural participation and more.

Lifetime achievement awards may go to artists, arts managers, arts advocates and others who strengthen a state's culture through decades of service.

Patron/Philanthropy awards recognize individuals (especially volunteers and donors), corporations and other entities that financially support the arts.
