Introduction

In conjunction with a comprehensive strategic planning effort, the Pennsylvania Council on the Arts (PCA) worked with the National Assembly of State Arts Agencies (NASAA) to design, conduct and analyze an on-line survey to receive input from constituents. The survey was intended to reach a large population of past and present grantees as well as other community organizations and stakeholders. The survey was designed to specifically ask about community development through the arts, which was an emerging theme within PCA's strategic planning interviews and focus groups. The survey asked PCA constituents across Pennsylvania—what is most important to supporting communities and what are their organizations currently doing to support communities. This method provided candid feedback for PCA related to community programs, services and satisfaction.

The survey was sent to arts organizations on PCA's mailing list and non-arts community organizations. Over four weeks in August and September 2018, the survey received a total of 534 responses, 383 of which were from arts organizations with a response rate of 31%. Responses came from all areas of the state, and all but three counties included at least one response. NASAA analyzed the geographic distribution and key demographics of respondents to assess the differences between survey recipients and respondents. NASAA weighed two questions by region to show the difference in results. Given the minimal effect of the weighting to the overall results of the survey, further analysis using weighted responses was seen as unnecessary. Overall, the weighted response effort helped verify the strongly representative sample of the survey by geography.

The following report provides key findings from the entire survey. Individual charts detail responses to each question—both questions asked of all respondents and questions asked only of arts or non-arts organizations. Cross-tabulations look at the relationship between the respondents' demographics (region, urban/rural, budget) and questions related to arts and communities.

Key Findings

About the Respondents

- We heard from 534 total respondents, 383 of which were affiliates of arts organizations and 151 were from non-arts community organizations or other.
- The response rate for arts organizations was 31%.
- Respondents came from every region and all but three counties in Pennsylvania. The geographic distribution of the respondents was representative of the state's population.
- 83% of respondents came from metro areas, 17% from non-metro areas.

Arts Organization Characteristics

- 72% of respondents were affiliated with arts organizations.
- The largest number of arts organization respondents were performing arts groups (29%).
- A majority of arts council respondents came from non-metro locations (59%).
- The largest disciplines represented in the survey were music, multi-disciplinary, theater and visual arts.
- A majority of organizations responding were small budget organizations (52%), with budgets under \$250,000.
- Overall, characteristics of arts organization respondents were representative of the relative characteristics of PCA grantees.

Non-arts Organization Characteristics

- 28% of respondents were from non-arts organizations.
- The largest segment of respondents in this category were from educational institutions.
- Most respondents had small expenditures on arts programming (Under \$50K).
- Non-arts organizations had higher percentages non-metro respondents than arts organization respondents.
- Responding non-arts organizations are actively providing arts programs and projects (73%).
- Of those, the top three types of programs were community arts programs, public awareness and arts education.
- 61% of non-arts organization respondents worked with arts organizations or creative businesses to provide programs.

Supporting Livable Communities through the Arts (All Respondents)

- All respondent groups reported that community arts programs and events were the most important to supporting livable communities through the arts.
- Public awareness of the arts, equitable access to the arts and arts education opportunities were rated as highly important for all respondents.
- Serving rural populations was more important to respondents from non-metro areas.
- There were no substantial regional differences in the activities rated as highly important (public awareness of the arts, equitable access to the arts and arts education).

- The northeast region placed the largest importance on serving rural and the southeast region placed the least.
- Respondents from the northeast indicated preserving traditional art forms was more important in comparison to those from other regions.
- Diversity in programming and audiences was higher in the southeast and Lehigh valley.
- Respondents from the northwest region in general rated many of the offered activities as less important, especially diversity related activities.

Arts Organization Responses


- The most significant barriers for arts organizations to contribute to livable communities were financial and economic. This was true across all regions. Getting the community interested in programs was also seen as a considerable barrier.
- Respondents in the central region noted higher transportation barriers. Respondents from Lehigh valley and southwest regions point towards lack of available space as a high barrier. Lack of space was also a larger issue in metro areas.
- When asked how their organization contributes to livable communities through the arts, respondents indicated their arts organizations' actions aligned with the perceived importance of contributing to livable communities.
- Larger arts organizations were more likely to indicate that they contributed to economic development and attracting and retaining workforces.
- Respondents believe PCA is doing a good job in supporting community arts programs, which is in alignment with its perceived importance.
- Many respondents were unaware of PCAs actions towards promoting the economic value of the arts in various forms.
- There were no large differences in perceptions of PCA's work between metro and nonmetro.
- Preserving traditional art forms was seen as PCA strength, though respondents indicated this was less important to supporting livable communities through the arts.

Populations Benefited by Programs and Services


- 70% of respondents said that their organizations' programs or services benefit children.
- 56% said their organizations benefit economically disadvantaged and 53% benefit senior/older citizens.
- Serving veterans and seniors were more frequently reported in the northeast.

Respondents by County




Respondents by Metro/Non-metro





What best describes the primary role of your arts organization?






What is your arts organization's operating budget in a typical year?





What best describes the primary role of your organization?




Primary role of non-arts organization by "Other" Category


What is your organization's total expenditures on arts programming in a typical year?






How important are each of the following to supporting livable communities through the arts? Please rate from "Not important" (1) to "Very important" (4).




What are some barriers to your organization's ability to contribute to livable communities? Please rate from "Not a barrier" (1) to "Significant barrier" (4).




In what ways does your arts organization / program contribute to livable communities through the arts?






How well does the PCA currently support each of the following to promote livable communities? Please rate from "Not at all well" (1) to "Very well" (4).



How important are each of the following to supporting livable communities through the arts? Please rate from "Not important" (1) to "Very important" (4).




Has your organization provided an arts program or project to your community in the last 12 months?




Did your organization work with an arts organization or arts business to provide programs for the community?





How important are each of the following to supporting livable communities through the arts?





Primary Role by Metropolitan Statistical Area (MSA)








Weighted Responses and Qualitative Section

Weighted Responses


Total respondents (510) were weighted based on the regional dispersion of 1,223 survey recipients (from the current and former grantee contact list). Geographic regions are based on 6 economic development regions in Pennsylvania (Central, Lehigh Valley, Northeast, Northwest, Southeast and Southwest). The percentage of the total population was proportional to the percentage of survey recipients in each region. A ratio between the percentage of survey recipients and the percentage of respondents in each region was calculated and applied to ensure responses were in proportion to recipients by region. Given the minimal effect of the weighting to the overall results of the survey, further analysis using weighted responses was seen as unnecessary. Overall, the weighted response effort helped verify the strongly representative sample by geography.

Please rate from "Not important" (1) to "Very important" (4).




Weighted question: Does your organization provide programs or services with the intention of specifically benefitting the following populations?




Open-ended Responses

While many open-ended/write-in responses were allowed as options in the survey, one question allowed for a broader chance for respondents to share their thoughts in an open text format. This question asked whether there was anything else they wanted to convey to PCA. NASAA analyzed and coded these responses by theme. The following charts show the percentage of themes within the open-ended responses. The largest thematic response by far was appreciation for PCA. A few other themes emerged including the need for more money both for a responding organization and for PCA, requests to know more about PCA, and arts and community related responses. Also included within this report is an export of all verbatim responses submitted during the survey period.

Is there anything else you would like to convey to the Pennsylvania Council on the Arts?

- Bring back PennPAT. This win-win program provided exposure to PA artists throughout the region and brought arts dollars here to PA. It also helped many artists in their professional development. It's a shame that internal politics at one funder led to the loss of this incredible program.
- 93% of all foundation funding is directed toward nonprofits in cities. Rural agricultural communities which represent 20% of the population in this country should be better supported. State funding agencies should skew funding to make up for the imbalance to rural nonprofits or they will fail.
- A 'mobile' art vehicle (like the bookmobile) that travels around the state to smaller municipalities to bring 'the arts' ... maybe a vehicle for 'music' and a vehicle for art that could make stops around the state for two days at each stop... at each stop they could partner with whatever the municipalities has to offer- an art gallery or council or a local symphony or orchestra.

- Funding received annually from the PCA is vital to the success and vitality of our organization. We truly appreciate this continued funding despite the lack of increased funding from the legislature.
- Funding, while important remains a small portion of our funding needs, and therefore
 we need to rely on both admissions and other forms of fundraising to support all of our
 special programming needs.
- Funds from the PCA are very beneficial to the work of individual artists. I have received a number of Project Stream Grants through the Lehigh Valley Arts Council and they have been crucial towards the success of my programs. Increased funding opportunities or amounts would be extremely helpful.
- Grant amounts are very small at the project level, but are nonetheless direly needed.
 The new on-line application is problematic. It has reduced the entire application to a
 few paragraphs, making it difficult for organizations to state their case. There needs to
 be more cultural awareness in general in PA. There needs to the PCA lobbying of
 corporations to contribute more.

The more middlemen there are between funding and art, the more opportunity for parochial decisions and poorly locally managed funding, and expanded bureaucracies. Please remember that you are PA Council on the ARTS, not on the Arts managers. Pittsburgh has a superficially thrilling rating as 16th on this list http://mcs.smu.edu/artsresearch2014/articles/blog-white-papers/top-20-most-vibrant-arts-communities-america-2017 But looking at the specifics puts Pittsburgh in 292nd for artists while plowing forward as 18th for arts and culture employees. This is an order of magnitude of difference, and failure. This is because the legacy institutions and GPAC suck up 80% of the funding and salaries. Most of these are moribund support for bureaucratic maintenance, what they do, and not serving Pgh or the arts, well.

- Professional training for community arts orgs. that may be run by artists without prior experience. I.E.: how to administer a non-profit, how to fundraise, how to do PR marketing or solicit professional services pro bono.

It is in many cases exactly these smaller NPO's that need the PACA financial support the most especially in rural communities such as Franklin County. - The Arts Underground thanks you for all you do!
- The Choristers is an auditioned community concert choir and is a recipient of program stream grants. The choir performs with professional orchestras and soloists 3 times a year. It is frustrating that after all the work we do for the grant application (and we are told our grant applications are stellar), the choir receives a \$3,000 grant. Please do not get this wrong. We are thankful for the grant. However, our annual budget is around \$90,000 per year. The grant is about 3.3% of our annual budget. Public documents show we receive the same grant as much, much smaller community choirs so the \$3,000 grant very well may represent 10% of their budget, if not more. Instead of a flat amount going to all successful applicants, it would be helpful if the annual budget of the arts organization could have some weight in determining the grant amount. I am not seeking some linear equation. Just have it be a factor in the equation.
- The Cultural Alliance of York County is a great help to us and the programs we specifically run for children. Without their assistance from the PA Arts Council those programs would not exist or would be greatly depleted. It seems that we go from year to year not knowing whether or not they will get any funds and therefore we don't know if we can continue our programs. They are great the consistency at the state-level not so much.
- The grant applications/forms/processes are a barrier for many community organizations, as you plan, consider changing the format and interfaces for grants.
- The partnership with the PCA allows us to grow as an organization in building relationships with organizations and individuals we may not typically have a relationship. Through the PPA we are able to further our knowledge and help bring about an awareness of the various programs available throughout our community.
- The PCA has been very supportive of our organization through Project and Program Stream grants and technical assistance grants. Thank you!
- The PPA program, through which we are funded, is great! We really appreciate the increase in funding this year, and the application and reporting process are not cumbersome at all. Also, our grant is administered via the GPCA, an GPCA staff, though they have changed frequently, have been consistently helpful and supportive of our PPA participation. Thank you all!!!!!!!

- The process to apply for Program and Project Stream grants is too time consuming for the amount of money an organization is granted. It takes many days to complete the cultural data reports as well as the PCA grant applications to receive a few thousand dollars. There is more staff time involved in the process than what the value of the grant is. Is there anyway to rethink the need for the Cultural Data Report?
- The Project STREAM program is amazing! I've been able to apply for a PCA Project STREAM grant at two out of the three museums/libraries I've worked for to support traveling and or temporary art exhibitions. The only issue is that sometimes our project begins before the grant is awarded, so we miss the opportunity to promote PCA effectively in our programs, but I also understand state budget years and the PCA's dependency on the state budget process and schedule.
- The small grant we receive has a HUGE benefit to our participants. Without this grant we simply could not afford an art program.
- The social development opportunities that accompany learning and creating art together
 are an important adjunct of our programs helping people maintain positive attitudes,
 address the rigors of daily living and contribute to society.
- There appears to be an oversaturation of arts and cultural entities in any given area, along with a growing number of presenting organizations? How is this trend affecting locally produced arts experiences? Are we promoting art or celebrity? The larger the cultural institution, the greater the responsibility to participate in research that truly measures the value of the arts. Where is the research on the AIE program which has been around for two decades but appears to have had very little impact on the state of arts-in-education in PA.
- There are a lot of intelligent and dedicated volunteers that struggle to promote the arts in their communities. I spend countless hours each year trying to secure funding and attention of various art projects. Local politicians and institutions are supportive but view the arts as something that will happen 'with or without' funding. They fail to put the full worth in the arts as a way to attractive businesses, tourists and permanent residents. We need help from the PCA to help drive the message home on a local level. Possibly meeting with local art organizations, city and county governments to pull resources and find ways to bridge barriers that cannot be done without combined effort.
- There is so much more arts organizations in smaller communities would love to do but it is very hard to raise money
- There is very high value and need for the PCA to impact state government and local arts councils.
- This arts program has become an integral part of my retirement life. I look forward to
 the days when I can attend art classes to learn new skills and techniques in creating art

- We are still unsure if someone received our PA Partners IN the Arts Grant. Having responsive employees on the PCA's end will help us to know if our application was received or not. It's hard to continue to apply for support when there is no acknowledgment of effort or response.
- We could use more support for our programming. Our budget has grown and it is all private support. I feel the state should be helping out more. The arts have been proven to support stronger communities and inner city development. More support would help us reach more people. Thank you
- We deeply appreciate the grant money that we receive from Pennsylvania Council on the Arts.
- We do appreciate everything you do!
- We do serve many audiences and have a significant core audience (high retention rate)
 of the following populations: economically disadvantaged groups, immigrant/ethnic
 populations, incarcerated persons, individuals speaking languages other than English,
 individuals with disabilities, people of color, senior/older citizens. I didn't list them
 because they attend the same programs or services as the general public, so I felt they
 were not "intentional" programs IE not a program only for individuals speaking
 languages other than English, etc.
- We greatly appreciate the financial support provided by the Grant distribution program. Without these funds, we would be hard pressed to provide classes/Materials for the clientele who are elderly and on fixed incomes. This gives them the opportunity to be creative, expressive, experimental, expansive and proud of their new accomplishments.
- We have a summer program, also in-service days and holidays where we provide a safe environment for children in our community thru arts and craft projects. We also have a

- sports program and need financial assistance for children who cannot afford to come to our facilityso that we can keep children off the streets and from learning bad habits.
- WE have a very serious and significant fear that the legislature will cut back or eliminate funding abilities for the arts. This would be an incredible negative blow to the forward progress made by so many communities in growing their community, including their business community.
- We have benefitted in many areas from the education and financial assistance from the PCA. We thank you for your hard work and for your focus on the arts in Pennsylvania.
- We have done programming on creative placing making (e.g., https://www.dvrpc.org/email/2012-09_Placemaking.htm, https://www.dvrpc.org/SOS/Roundtable/, and in our Regional Community and Economic Development Forum https://www.dvrpc.org/Committees/RCEDF/) and the Pop Up Economy (https://www.dvrpc.org/SOS/Roundtable/pdf/2015-01-09_Gober.pdf) We also do some work with tourism and reach out to arts-related organizations for that programming.
- We have enjoyed working with our local arts councils. Our seniors have been very receptive to the programming provided.
- We have the occasional communication how the arts impact Pennsylvania but nothing
 that would allow us to specifically answer all the questions. The grant that we receive
 annually is appreciated but is not sufficient to allow us to move ahead in leaps and
 bounds.
- We need artist in residence programs to return to schools.
- We need diverse leadership that reflects the cultural values of the communities intended
 to be served. We hope that cultural sensitivity is a major component when selecting
 leadership to represent the council. We also need additional support to underserved
 populations looking for opportunities to make positive changes with limited leadership
 experience.
- We need updates and information as to what they are doing these days,
- We only received nominal funds through the project stream over the past 10 years as well as programming through Millersville Central PaArtners which are PCA funds. We need consistent program funds. We operate over 13,000 sq ft of space in the downtown city for art programs without paid staff, so having volunteers to do grant writing only to receive \$1000-\$1500 of state funds is unsustainable. We operate multiple art programs and educational programs for kids throughout the year in addition to new gallery exhibits each month that are open to the public.
- We present seven chamber music concerts during the academic year. This will be our 38th consecutive year. This year we are moving from the county library to a local church which will accommodate a larger audience. Our our art gallery is on hold because the restaurant in the historic mill has been closed. We present seven concerts in the town park on Sunday evenings; this is the 38th year for this series, also. Over the past 2 years we have moved an 1869 railroad freight house, which had been scheduled for demolition, to the the town park adjacent to an old railroad station. It will house a museum. Our historic preservation committee is starting a foundation to aid in the preservation of historically important structures. We maintain two demonstration

- gardens in the town park (Edible Landscape; PollInator). We present the Bellefonte Victorian Christmas Arts & Crafts Show in early December (since 1982).
- We receive our grant thru the Berks Arts Council. Thank you
- We sincerely appreciate the support which was provided to New Freedom Theatre over the years. By giving us consistent support, the theatre was able to provide arts opportunities to a underserved population as well to provide opportunities for artists to work.
