



Creative-sector advocates and state arts leaders are navigating a rapidly changing and unpredictable policy environment. As pandemic relief funds sunset, state budgets are under renewed stress, which can adversely impact arts funding. Simultaneously, 5,793 state legislative seats are up for election in November. That means legions of new lawmakers must be educated about the important impacts of the creative sector. How can advocates and arts leaders position the arts as an essential public investment? How can we cultivate new champions across the political spectrum? Exchange tactical strategies that work in this dialogue based session.

(Re)Branding Your Agency San Geronimo, 2nd Floor

An effective branding strategy can help your agency stand out and allow your constituents to build more meaningful connections with you. Your brand communicates who you are and reflects the heart of your work, encapsulating why participants, partners and supporters should believe in you. This session explores why and how some of your state arts agency and regional arts organization peers decided to undertake the process of rebranding to better resonate with their goals and vision.

This session explores that evolving legal landscape and its potential implications for grant making and compliance. Maria Rosario Jackson, Ph.D., chair of the National Endowment for the Arts (NEA), joins the Assembly to share the latest developments in the NEA's work to unlock new opportunities for American communities to thrive through the arts. NASAA 2024 LEADERSHIP AWARDS

NASAA's leadership awards showcase best practices of state arts agencies and regional arts organizations, recognize exemplary leadership, and demonstrate how government creatively, effectively and efficiently serves the public through the arts.

LUMINARY AWARD FOR TRANSFORMATIVE EXECUTIVE LEADERSHIP

This award recognizes an executive director who makes a significant contribution to public support for the arts at the state, regional and national levels. Awardees exhibit remarkable qualifications such as exemplary and inspirational leadership, innovative thinking and dedication to diverse artistic expression. The Luminary Award is inspired by Gary Young, an early leader in the state arts agency field.

Carlos R. Ruiz Cortés. Ph.D. Executive Director, Instituto de Cultura Puertorriqueña

Carlos Ruiz Cortés was appointed in January 2017 as executive director of the Instituto de Cultura Puertorriqueña (ICP) to implement and oversee public policy for arts, culture and heritage. He manages 200+ employees and contractors, over 35 historic buildings (including two theatres), the National Art Collection, the General Archive and the

National Library. Dr. Ruiz Cortés supervises 18 divisions of the state, including Archaeology and Built Heritage.

Dr. Ruiz Cortés is renowned for advancing ICP's mission and vision through many challenges, including severe budget cuts (90%) in 2017, followed by devastating hurricanes Irma and María the same year, earthquakes in 2020, and the COVID-19 pandemic. Under his leadership, ICP has established longterm partnerships that benefit its constituents and increase access to Puerto Rico's heritage. Activities include internships, digitization projects, the annual celebration of multiple cultural festivals, and active relationships with the Puerto Rican diaspora.

During Dr. Ruiz Cortés's tenure, folk arts traditions were recorded and distributed online, as well as on local television, resulting in two Emmy Awards. ICP was honored as a guardian of Puerto Rican heritage with the 2023 National Ceiba Award, presented by the National Museum of Puerto Rican Arts & Culture. Other recipients of this award include Ricky Martin, Jimmy Smits and Rita Moreno, among others.

From 2018-2023, Dr. Ruiz Cortés served simultaneously as the executive director of the Corporación de las Artes Musicales, the public corporation of the Symphony Orchestra of Puerto Rico. He holds a Ph.D. in history from the Interamerican University of Puerto Rico. He is a board member of Mid Atlantic Arts.

DISTINGUISHED PUBLIC SERVICE AWARD

This award honors a chair or council member whose outstanding service, creative thinking and exemplary leadership significantly impact public support for the arts at the state level and across the country.

Geraldine B. "Ginger" Warner Chair, Ohio Arts Council

Ginger Warner is a retired attorney who practiced private and corporate law in New York, Maryland, California and the District of Columbia. Since moving to Ohio in 1983, Ginger has devoted much of her life to her passion for the arts and, in doing so, empowered others to pursue their creative potential and access arts and cultural experiences in diverse settings. She currently serves as chair of the Ohio Arts Council (OAC), a position she has held since 2016, previously serving as vice-chair from 2011-2016. She began her OAC board service in 1997 and has since been appointed by five consecutive Ohio governors spanning the political spectrum.

Ginger's board and volunteer service reaches across Ohio, including service to the National First Ladies Library and Museum in Canton and the Cleveland Orchestra. In the Greater Cincinnati area, she has served with the Taft Museum of Art, Ensemble Theatre, May Festival, Madisonville Education and Assistance League, Children's Hospital Medical Center, University of Cincinnati, Hamilton County Park District, Cincinnati Symphony Orchestra, Cincinnati Opera, and Greenacres Foundation. She is a founder of The Harmony Project at the Cincinnati College-Conservatory of Music (CCM) and Books for Lunch at Seven Hills School. Ginger also established the Warner Fellowship in Law and Women's Studies at the University of Cincinnati and the May Festival Fellowship in Choral Conducting at CCM. Ginger is a member of the University of Cincinnati's Circle of Honor Benefactors.







NASSA 2024 LEADERSHIP AWARDS

DIVERSITY, EQUITY AND INCLUSION AGENCY AWARD

This award recognizes the policies, practices and programs of state arts agencies or regional arts organizations that embrace and advance diversity, equity and inclusion (DEI) at the state or regional level. Awardees demonstrate innovative and exceptional efforts to be diverse, equitable and inclusive in their work.



Maryland State Arts Council

The Land Acknowledgement Project of the Maryland State Arts Council (MSAC) is a collection of resources centering the

experiences of Indigenous people in the place now known as Maryland. The project includes a statewide Indigenous land acknowledgement statement read aloud at the beginning of all MSAC public meetings, a resource guide with an overview of land acknowledgement statements and how arts agencies and artists can ethically create their own, recommendations for how non-Indigenous people may move toward positive change led by tribal peoples, and maps and resources on tribal histories. The project was developed in consultation with the Accohannock Indian Tribe, Assateague People's Tribe, Choptico Band of Indians of the Piscataway Conoy Tribe, Nause-Waiwash Band of Indians, Piscataway Indian Nation, Pocomoke Indian Nation, Susquehannock Indians and Youghiogheny River Band of Shawnee, in response to ongoing constituent requests. At MSAC, project efforts were led by Folklife Specialist Ryan Koons.




Since its release in 2022, the project has consistently fulfilled its intended purpose of combating Indigenous erasure, building networks that promote Indigenous sovereignty, and beginning to facilitate the development of ethical relationships between settler institutions and tribal peoples. In addition to spurring more than 24 requests for presentations, the project has led to convenings and collaborations among state agencies, private organizations and tribal leadership resulting in tools raising the visibility of Indigenous people via the Maryland State Archives, curriculum development increasing Indigenous perspectives in Maryland public schools, and efforts to connect tribal peoples with the resources of arts organizations and higher education institutions. Revisions that keep the Land Acknowledgement Project updated, accessible, and as accurate as possible are ongoing at MSAC.

Ayanna Lalia Kiburi (she/her), MPH **Deputy Director, California Arts Council**

Ayanna Lalia Kiburi serves as the deputy director of the California Arts Council (CAC). A self-proclaimed "artivist," she is known for her transformative leadership in the arts and public health sectors.

In her 20+ year career in public service, Ayanna has created more equitable and inclusive work environments, advanced policies that promote progressive institutional change, and championed creativity as the way to build and nurture sustainable systems. As a public health expert, she has advocated for addressing health disparities within historically disinvested communities. Her approach to DEI is grounded in a deep understanding of systemic inequities and a commitment to fostering practices that result in individuals and communities thriving-living unencumbered by entrenched systemic racial inequities.

For the past eight years, Ayanna has overseen several complex DEI and operational initiatives at the CAC, including implementation of the CAC's 2020-2027 Strategic Framework. The Framework is grounded in addressing racial inequity root causes, establishing policy, and using the Decision Support Tool (DST), which has been shared statewide and nationally. She led a change management initiative called Ways of Working that centers workplace psychological safety and belonging and facilitates a process that counters standard work practices grounded in White supremacy. She established the first race equity manager and equity measures and evaluation manager positions at the agency. Her appointment to Gov. Gavin Newsom's San Quentin Transformational Advisory Council in 2023 was thanks to her exceptional leadership in the CAC Arts in Corrections Program.

Ayanna has an M.A. in public health and a B.A. in sociology and African American studies. She is the creative director of a readers theatre ensemble called Authentic Voices that explores racial trauma, healing and belonging through personal stories and music. She enjoys exploring life and art with her wife, son and fur baby in Sacramento.


